WHAT CAN DELAWARE OFFICIALS DO?

GUARANTEE ACCESS TO REPRODUCTIVE HEALTHCARE

Delaware officials must create reliable, permanent streams of reproductive healthcare funding for providers, patients who do not qualify for state Medicaid coverage, abortion funds, and practical support organizations.

EXPAND THE SHIELD LAW

Delaware officials must ensure shield law provisions explicitly apply to federal actions and extend these protections to cover gender affirming care.

WHAT CAN DELAWARE OFFICIALS DO?

GUARANTEE ACCESS TO GENDER-AFFIRMING CARE

Delaware's Medicaid program must add explicit coverage mandates to ensure trans and non-binary people can access the care they need, including gender-affirming care.

EXPAND THE SHIELD LAW

Delaware officials must ensure shield law provisions explicitly apply to federal actions and extend these protections to cover gender affirming care.

PROTECT LGBTQ+ RIGHTS IN EDUCATION

The Attorney General needs to clarify that Delaware law protects vulnerable students, including LGBTQ+ individuals, from discrimination.

WHAT CAN DELAWARE OFFICIALS DO?

ICE & IMMIGRATION RAIDS

Delaware officials must refuse to cooperate with federal threats to our immigrant communities. We cannot back down when federal officials threaten to cut off funding for non-cooperative states.

ICE & SENSITIVE LOCATIONS

Delaware lawmakers must pass legislation prohibiting civil arrests without a valid warrant or court order in or around sensitive locations. Sensitive locations include courthouses, medical facilities, schools/childcare centers, government buildings, places of worship, and police stations.

STATE RESOURCES FOR IMMIGRANTS

Delaware needs to expand and publicize state-based assistance programs that cover immigrants, including recently arrived migrants and asylum seekers, to ensure they can access critical services like medical care and food assistance.

ICE Y REDADAS DE INMIGRACIÓN

Los funcionarios de Delaware deben negarse a cooperar con las amenazas federales a nuestras comunidades de inmigrantes. No podemos dar marcha atrás cuando los funcionarios federales amenazan con cortar los fondos para los estados que no cooperan.

ICE Y LUGARES SENSIBLES

Delaware debe aprobar una legislación que prohíba los arrestos civiles sin una orden judicial válida o una orden judicial en o alrededor de lugares sensibles. Los lugares sensibles incluyen juzgados, instalaciones médicas, escuelas/guarderías, edificios gubernamentales, lugares de culto y comisarías de policía.

RECURSOS ESTATALES PARA INMIGRANTES

Delaware necesita expandir y publicitar los programas de asistencia estatales que cubren a los inmigrantes, incluidos los migrantes recién llegados y los solicitantes de asilo, para garantizar que puedan acceder a servicios críticos como atención médica y asistencia alimentaria.
